## "SOMETHING TO PRAYERFULLY CONSIDER"

This past week I attended Region 4 Spring Pastor's Conference at Beautiful Savior Lutheran Church in Sarasota. The presentations given were mostly tools offered by Lutheran Church Extension Fund (LCEF). Some LCEF programs for congregations are free and others come with a minimal cost. Only God's grace is completely free and eternal. Anyway, our closing devotion focused on STEWARDSHIP. Usually that word sends the congregate running because we associate STEWARDSHIP with tithing, money, and budgets. Here's some food for thought: God is the owner of His entire creation and everything in it. We are managers of all that belongs to the Owner. We are accountable to the Owner and ALL He gives us to manage, such as our time, talents, gifts, money ... everything.



We have also learned in the Small Catechism under the first Article of the Creed:

I believe that God has made me and all creatures; that He has given me my body and soul, eyes, ears, and all my members, my reason and all my senses, and still takes care of them.

He also gives me clothing and shoes, food and drink, house, home, wife and children, land, animals, and all I have. He richly and daily provides me with all that I need to support this body and life.

He defends me against all danger and guards and protects me from all evil. All this He does out of fatherly, divine goodness and mercy, without any merit or worthiness in me. For all this it is my duty to thank and praise, serve and obey Him.

This is most certainly true.

Here is what was presented in our closing devotion:

#### BIBLICAL WISDOM TO GUIDE OUR GIVING

- 1. Let our giving BE AN ACT OF FAITH. God is the owner, we are the managers. We can manage what He has given us with confidence, for He has promised to provide.
  - Seek first the kingdom of God and His righteousness, and all these things [food and clothing, the necessities of life] shall be yours as well. Matthew 6:33
  - My God will supply every need of yours according to His riches in glory in Christ Jesus. Philippians 4:1
- 2. Since it is the Lord whom we seek to glorify with our gifts, let us give Him OUR FIRST AND BEST [first fruits].
  - Honor the Lord with your substance, and with the first fruits of all your produce. Proverbs 3:9
- 3. May our offerings be made REGULARLY as AN ACT OF WORSHIP.
  - On the first day of every week, each of you is to put something aside and store it up, as He may prosper, so that contributions need not be made when I come. 1 Corinthians 16:2

#### **VISION PATH**

Community Awareness of Our Mission and Activities:

Are we physically isolated from the community? Have you ever asked a person who you just struck up a conversation with at the Rt. 776 Walmart: "Do you know about Redeemer Lutheran Church?" The response might be "Redeemer who!" The physical or geographical isolation has surfaced from time to time over the years as to how it has impeded the fulfillment of our community missions, and more relevant the attainment of our recently identified vision paths.

Over the last six months this generic need has surfaced more formally. For instance, several of the responses to the Synod-based LCEF Open-Ended Survey (August, 2014, pp. 2-7) included need statements such as: "that's the church off the highway"; "I am not sure many people even recognize our existence"; "I think the majority of the community doesn't know Redeemer is here"; "As a somewhat unknown entity"; and "nice little church if they ever heard of Redeemer". It appears that we really need to rebuild our image and create a visible entity for guiding our surrounding community as identified in our recently developing vision paths.

From another perspective emanating beyond the walls of Redeemer, it was expressed (LCEF Open-Ended Survey Executive Summary, September, 2013, pp. 1-2) that, "does a relationship really exist between the congregation and the surrounding community? A plurality of the respondents wondered if the community has much awareness of Redeemer. Still to be determined is the issue of making a difference in the community by engaging it as Christian citizens (p. 2)."

Also, recently from an external perspective, a report (March 2014, pp. 1-2) from a site visit by the LCEF Architectural Advisory Committee focused on possible expansion opportunities for the existing Church property and how they relate to the recently identified vision paths (January, 2014, pp. 5-11). This issue of community awareness of Redeemer, its mission and related vision paths has been addressed in the form of a recommendation:

The church owns 10-12 acres in a residential neighborhood with no immediate exposure to the main highway. Church does own a single residential parcel contiguous to its property but not immediately visible from the highway. A corner lot on the main highway and main road to the Church is potentially available for purchase. It is strongly recommended that inquiry into this property for potential purchase for use as signage and "community room" for large number of groups that currently use the Church facilities during the week. It is also suggested that this may want to become a high priority for the congregation. Fulfillment of the identified vision paths could all be met in the development of the corner lot.

Is this recommendation a "charge" for the Church Council and its <u>ad hoc</u> Vision Path Development Team to prepare a realistic strategic plan for the Voters Assembly consideration and prayerful deliberation? Do we need a symbolic locomotive (property acquisition and development) to move us to the fulfillment of our identified vision paths and the realization of our community mission? What do you think? Let us hear from you!!

# **EASTER SUNDAY 2014**









Beloved in Christ, many of you have asked me recently about our grandson Angel's progress with his leukemia. As many of you know Angel was diagnosed with leukemia 2 years ago this month after a bout with paralysis to the right side. The diagnosis was of course scary to the entire family but most especially to our dear Angel.

Although the path has been scary and has caused a great deal of family strife, Angel has been an exceptional example of bravery in the face of fear. He has undergone a myriad of chemotherapy treatments with the poise of a adult. Each month for yet another year he will continue to receive chemotherapy treatments. Every 3 months the treatment is administered through a spinal tap. Although most of these treatments his body has handled well, some have not. This past September he was hospitalized yet again with low blood counts and some minor TIA's. He was also recently diagnosed with hepatitis. The hepatitis appears to have been contracted through all of the blood transfusions he has

received. This in my eyes is equally scary because unlike the cancer there is no cure for it. Although all of these experiences are difficult for a child to understand and deal with, he continues to be a child, he loves to read, play on his tablet, read to his brother and love his super heroes and his sports teams.

Even within the adversity of leukemia he has proven to grow exceptionally. Angel is now 8, physically he has gotten taller, his hair has grown back and he is maintaining weight. e Prior to his diagnosis his grades were average, because of the diagnosis and the lack of energy to play the way he formally did, he has risen to an "A" student; this because of his new found love of reading. It is safe to say that even in the midst of trials God provides avenues of escape even for a little boy.

As you all know we do not know what the future holds for Angel but we are sure that our Lord is holding him in the palm of His hand. We pray for His continued mercies and protection for our dear Angel. We pray that Angel can maintain his wonderful attitude within this trial. We pray that our daughter and son in law maintain grace within this trial, remembering that God is gracious and merciful. Thank you to all of you for your thoughtfulness and prayers, and our request continues, please continue to keep Angel in your prayers as he finishes his chemotherapy in the next year.

## **ENDOWMENT FUND MOVES...**

#### **Endowment Fund Moves to LCMS Foundation**

As some of you may know our Endowment Fund has for several years been under the management of Thrivent, through the Thrivent Trust Company. Earlier concerns were expressed by our LCMS President and other Lutheran Synod officials concerning Thrivent support of abortion providers through its Choice Dollar program.

Thrivent reaction to LCMS and other Synods expressed concerns, was to stop providing such support to <u>both</u> prochoice and pro-life organizations. This promoted the Endowment Committee to question our continued relationship with Thrivent and to review what our alternatives were for Custodial and Investment services for our Endowment Fund, which would better reflect our Christian beliefs.

During our review of alternatives we found the required services in and through a totally LCMS Lutheran organization the LCMS Foundation. As a bonus to us at a fee structure less than ½ of the fees at Thrivent. Also there was some concern for our recent investment performance at Thrivent. All this encouraged us to make a change. As a result we have established a Custodial Account with LCMS Foundation. Recently we instructed Thrivent Trust to liquidate our Endowment Fund Account there and to wire the proceeds of that liquidation to our newly established account at LCMS Foundation.

In late March 2014, a wire transfer for \$502,000.00 has been received by the Foundation which will be invested as we have indicated in our Custodial Account Investment instructions we completed in establishing our Custody account with the Foundation. The new account carries the name of "Redeemer Lutheran Church Endowment Fund" and has the account number of CU900027384.


The chart also indicates the significant events along the time line. This includes the Gifts received, the Grants and the loan the fund has made along the way.





#### CHRISTIANS KILLED FOR FAITH NEARLY DOUBLED IN 2013

Rev. Faye Pama Musa knew immediately why suspected Boko Haram militants burst into his home last year as his wife prepared dinner in the family's northeastern Nigeria home. His stance against Christian persecution in the divided African nation had long made him a target.

Musa, who served as the general overseer of the Rhema Assembly International Church and secretary of the Christian Association of Nigeria (CAN) in Borno, saw the intruders near the front door of his home in Maiduguri as his wife, Mercy, prepped food. One of the couple's daughters, Zion, had spotted the armed men just seconds earlier jumping a fence.

'Today you are a dead man,' one of the gunmen reported said on May 14 as he dragged Musa to the porch. 'Call your Jesus to help you, Mr. CAN man!'

Zion Musa then begged the attackers to spare her father, a request met with a misfired bullet that caused her to faint. She survived but her 52-year-old father — a man who worked closely with Open Doors, a nondenominational group tracking persecuted Christians worldwide — did not.

Musa, according to the group, was one of 2,123 Christians killed last year due to their faith, compared to 1,201 in 2012. More than half of those reported killings (1,213) occurred in Syria, followed by Nigeria (612) and Pakistan (88).

But North Korea — a country of more than 24 million, with an estimated 300,000 Christians — remained the most dangerous country worldwide for Christians for the 12th consecutive year, followed by Somalia, Syria and Iraq.

"Like others in that country, Christians have to survive under one of the most oppressive regimes in contemporary times," according to a release on the report issued Wednesday. "They have to deal with corrupt officials, bad policies, natural disasters, diseases and hunger. On top of that, they must hide their decision to follow Christ. Being caught with a Bible is grounds for execution or a life-long political prison sentence. An estimated 50,000 to 70,000 Christians live in concentration camps, prisons and prison-like circumstances under the regime of leader Kim Jong-Un."

A sub-Saharan African country — Somalia — was ranked second on the organization's list for the first time. Islamic extremism is the primary source of Christian persecution in the country of more than 10 million and while the capital of Mogadishu is under more moderate Muslim control recently, converts from Islam are threatened with execution, sometimes by the al-Shabaab militant rebels.

"In Somalia, a Christian cannot trust anyone," one Christian reportedly told an Open Doors researcher. "One false confidence and you literally lose your head."

Syria, meanwhile, which had not previously cracked the group's list of top ten most oppressive places for Christians, ranked third last year. Like in Somalia, Islamic extremism powered the prosecution, according to Open Door officials, and many towns that previously had large populations of Christians have become ghost towns.

'The face of persecution in Syria has changed,' the group's World Watch List reads, adding that nearly half of rebels in Syria have a jihadist background. 'The influence of these groups that are linked to Al Qaeda and other extremist factions has risen considerably in the past year.'

More than 80 percent of people worldwide identify with a religious group, according to 2011 survey by the Pew Forum on Religion and Public Life. Of those, 2.2 billion, or 32 percent, identified themselves as Christians, followed by 1.6 billion Muslims (23 percent) and 1 billion Hindus (15 percent).

The survey also found that roughly 1.1 billion people, or 16 percent worldwide, have no religious affiliation, making that segment the third-largest religious group globally and roughly equal in size to the world's Catholic population." Author: Joshua Rhett Miller, published January 10, 2014






